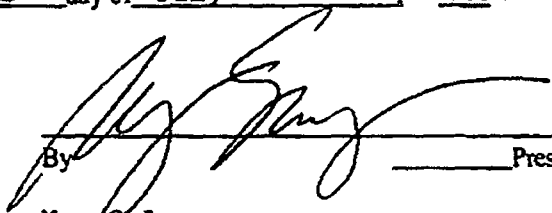

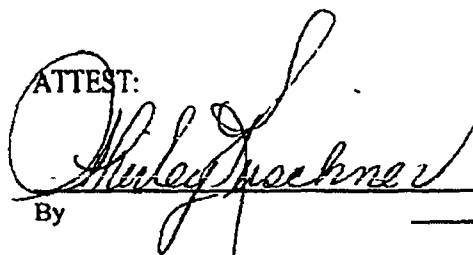

**DED AND RESTATED CERTIFICATE OF INCORPORATION

The undersigned corporation, organized and existing under and by virtue of the Oklahoma General Corporation Act, for the purpose of amending and restating its certificate of incorporation, hereby certifies:

1. The name of the corporation is:

ROTARY CLUB 29 FOUNDATION

2. The address, including the street, number, city and county, of the corporation's registered office in this state is Suite 1909, 120 North Robinson, Oklahoma City, Oklahoma County, Oklahoma 73102. The name of the corporation's registered agent at this address is Shirley Kirschner.

3. Subject to the limitations set forth in this Certificate, the corporation is formed for charitable purposes and to engage in charitable and educational activities, subject to the limitations applicable to not-for-profit corporations in the Oklahoma General Corporation Act. The Foundation's activities shall be exclusively focused on providing support for the philanthropic projects of the Rotary Club of Oklahoma City (the "Club"), an Oklahoma not-for-profit corporation, in accordance with a spending policy adopted by the Board of Directors and members of the corporation (the "Spending Policy") in accordance with Section 12 of this Certificate and the Bylaws of the corporation. Subject to the foregoing, the corporation shall have and may exercise all of the powers of nonprofit corporations under Oklahoma law.

4. In fulfilling its objectives and purposes, the corporation shall be subject to the following limitations:

- (a) The corporation shall not carry on any activity that is not permitted to be carried on by a corporation described in Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Code"), which is exempt from federal income taxation (all references herein to the Code shall include references to any corresponding provisions of any subsequent tax law).

- (b) At no time, either on or before dissolution, shall any part of the funds or assets of the corporation inure to the benefit of any private individual, nor be used for the purpose of carrying on propaganda or otherwise attempting to influence legislation, except as permitted in this Certificate and the Code. The corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office.

- (c) If the corporation is found to be a private foundation, defined in Section 509 of the Code, the corporation shall conduct its business and distribute its income as necessary for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Code.

(d) If the corporation is found to be a private foundation, defined in Section 509 of the Code, the corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code, shall not retain any excess business holdings, as defined in Section 4943(c) of the Code, shall not make any investments in such a manner as to subject the corporation to tax under Section 4944 of the Code, and shall not make any taxable expenditures, as defined in Section 4945(d) of the Code.

(e) No director or officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation (other than a not-for-profit organization described in Section 501(c)(3) of the Code as provided in Section 7 of this Certificate).

5. This corporation is formed as a not-for-profit corporation and shall not issue capital stock. The rights, privileges, prerogatives and conditions of membership, if any, shall be stated in the corporation's Bylaws. The members of this corporation are the Directors of the Club.

6. The corporation shall not afford pecuniary gain, incidentally or otherwise, to its members.

7. A Board of Directors consisting of not less than nine members shall manage the business and affairs of the corporation. The number, qualification, and method of election of the Directors of the corporation shall be as stated in the corporation's Bylaws.

8. Upon dissolution, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the corporation, dispose of all of the assets by transferring and conveying the assets to one or more charitable, religious or educational organizations exempt from taxation under Section 501(c)(3) of the Code as determined by the Board of Directors.

9. The power to adopt, amend or repeal the Bylaws of the corporation is hereby conferred upon the Board of Directors, subject to approval by a majority of the members of the corporation, except as provided in Section 12 of this Certificate.

10. To the fullest extent now or hereafter permitted by Oklahoma law, a director of this corporation shall not be liable to the corporation or its member for monetary damages for breach of fiduciary duty as a director.

11. This Certificate may be amended by a vote of the Board of Directors of the corporation, subject to the approval of the members of the corporation, except as provided in Section 12 of this Certificate.

12. The Board of Directors shall adopt, maintain, and at all times operate the business and affairs of the Foundation in accordance with, the Spending Policy.

(a) The Spending Policy shall provide for the availability of funds to support the philanthropic activities of the Club in reasonable amounts and for the protection and growth of Foundation assets for the long-term support of such purpose. All distributions of funds of the corporation will be subject to the ultimate control of the Board of Directors of the corporation

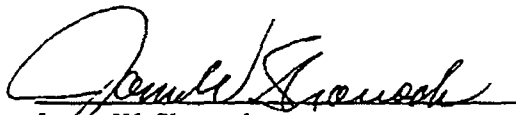
and no distribution of corporation funds shall be authorized except as approved by the Board of Directors of the corporation.

(b) The adoption of the Spending Policy, and the adoption of any proposal to amend, modify, or terminate the Spending Policy, the Bylaws with respect to the Spending Policy, or this Section 12 of this Certificate, shall require the approval of not less than two-thirds (2/3) of the members of the Board of Directors of the Foundation present at a regular meeting of the Board of Directors of the Foundation and approval of not less than two-thirds (2/3) of the members of the Foundation present at a meeting of the members of the Foundation, to be held in conjunction with a regular meeting of the Board of Directors of the Club. In addition, following adoption of this Certificate, the Bylaws, and the Spending Policy, prior notice of any such proposal to amend, modify or terminate the Spending Policy, the Bylaws with respect to the Spending Policy, or this Section 12 of this Certificate, shall be given to members of the Club, which notice shall include an opportunity to attend and participate in any meeting of the Board of Directors or members of the Foundation at which such proposal will be considered.

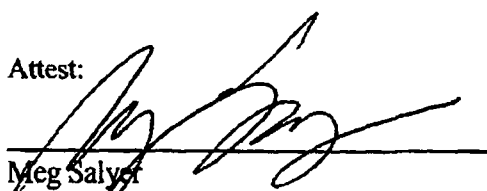
(c) In no event shall this Certificate, the Bylaws, or the Spending Policy be amended, modified, or terminated, and no special distribution of funds of the corporation shall be made, if the effect of any such action would adversely affect the tax status of the corporation. The corporation's Board of Directors may, at its option, require an opinion of tax counsel as a condition to the adoption of any such amendment, modification, or termination or the disbursement of such special distribution.

This Amended and Restated Certificate of Incorporation was duly adopted in accordance with the provisions of Title 18, Section 1080 after being proposed by the governing body of the corporation and approved by the members of the corporation in the manner and by the vote prescribed in Title 18, Section 1077, and further amends, integrates, and restates the certificate of incorporation of the corporation.
