The Organization builds on the strengths and potential in the community through education, character formation, and personal development. The goals of KidWorks are to 1) be a model of community transformation by building on existing community assets, 2) be a safe haven for youth and families, and 3) be a place for learning, nurturing, and leadership development. On a weekly basis KidWorks serves over 800 children, youth and parents living in under-resourced neighborhoods and additionally over 4,000 community members annually at 4 community centers in central Santa Ana, CA.
