Attendees learn how to identify and target areas of personal interest and align giving with their priorities. During the year ended June 30, 2017, approximately 30 individuals attended a philanthropy education workshop or retreat hosted by the Foundation.

Research The Foundation engages in landmark original research, as well as leverages leading research from organizations around the world, to guide our granting, inform our donors and partners, and strengthen our credible voice for women and girls.
