Community Organizing, Leadership Development, and Civic Engagement: Our community organizing programs are working to empower Chinese and Vietnamese Immigrants as well as Asian and Pacific Islander youth. They are working on community driven solutions in housing and transportation and improving educational outcomes. This includes participating in a successful coalition that passed a bill requiring public schools in Oregon have ethnic studies curriculum. This year we also continued our work developing new leaders through the Asian Pacific Islander Community Leadership Institute and neighborhood leaders of SE Portland through our Climate Health and Housing Institute. Finally, our civic engagement programs has built a statewide network of API led organizations that works together in registering new voters, civic education, and getting out the vote.

Policy Advocacy, Coalitions, and Fiscally Sponsored Community Groups: Our policy advocacy and coalition work is focused on housing, transportation, education, and access to health care. This includes participating in and shaping the development and implementation of new regional transportation and housing bonds. Our coalition work includes participating in coalitions supporting immigrants rights such as One Oregon, responding to hate crimes through Portland United Against Hate, and participating in the Coalition of Communities of Color. Our fiscally sponsored community groups are working on similar issues including developing and implementing a community health improvement plan with the Oregon Health Equity Alliance in Multnomah County and also registering COFA migrants in a new healthcare plan with the Oregon COFA project.

Jade District: The Jade District is a place based community building and economic development program. Within it we are working to improve health outcomes for our target neighborhoods with an eye to preventing involuntary displacement. This includes the development of new affordable housing and community centers, public engagement around a new transit line and safety improvements, and development of parks and green space. The Jade District also acts as a hub for neighborhood services in small business technical assistance, storefront improvement, tenant counseling, and workforce navigation.

AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
APANO COMMUNITIES UNITED FUND

ARTICLE 1

The name of the corporation is APANO Communities United Fund (the "Corporation").

ARTICLE 2
Type

The Corporation is a public benefit corporation.

ARTICLE 3
No Members

The Corporation will not have members.

ARTICLE 4
Purposes and Powers

- 4.1 General Purpose.** The Corporation is organized and shall be operated exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), including, without limitation, to create cultural awareness advance social justice and equity to improve the welfare of Asian and Pacific Islander Americans.
- 4.2 Net Earnings.** No part of the Corporation's net earnings may inure to the benefit of any private shareholder or individual
- 4.3 Prohibited Activity.**
- (a) No substantial part of the activities of the Corporation shall be devoted to attempting to influence legislation by propaganda or otherwise, except to the extent that an organization exempt from federal income tax under Section 501(c)(3) of the Code can engage in such activities without incurring any penalties, excise taxes, or losing its status as an organization exempt from federal income tax under Section 501(c)(3) of the Code. The Corporation shall not, directly or indirectly, participate in or intervene in (including by the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. The Corporation shall not have objectives or engage in activities that characterize it as an "action" organization within the meaning

of the Code.

(b) Notwithstanding any other provisions of these Articles of Incorporation, the Corporation shall not conduct or carry on activities not permitted to be conducted or carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Code or by an organization contributions to which are deductible under Section 170(c)(2) of the Code.

(c) The Corporation is prohibited from engaging in any excess benefit transaction as defined in Section 4958(c) of the Code.

(d) The Corporation is prohibited from engaging in any act of self-dealing as defined in Section 4941(d) of the Code, from retaining any excess business holding as defined in Section 4943(c) of the Code that would subject the Corporation to tax under Section 4943 of the Code, from making any investments that would subject the Corporation to tax under Section 4944 of the Code, and from making any taxable expenditure as defined in Section 4945(d) of the Code. If Section 4942 of the Code is deemed applicable to the Corporation, it shall make distributions at such time and in such manner that it is not subject to tax under Section 4942 of the Code.

4.4 Powers

In general, and subject to such limitations and conditions as are or may be prescribed by law, by these Amended and Restated Articles of Incorporation, or by the bylaws of the Corporation, the Corporation shall have the authority to (a) engage in any and all such activities as are incidental or conducive to the attainment of the purposes of the Corporation set forth in Section 4.1 of these Amended and Restated Articles of Incorporation and (b) exercise any and all powers authorized or permitted under any laws that are now, or hereafter may be, applicable or available to the Corporation.

ARTICLE 5

Liability of Directors and Uncompensated Officers

The personal liability of a member of the board of directors or uncompensated officer to the Corporation for monetary damages for conduct as a director or officer is eliminated or otherwise limited to the fullest extent permitted by law.

ARTICLE 6

Indemnification

- 6.1 Indemnification.** The Corporation shall indemnify to the fullest extent authorized by law any current or former director of the Corporation who is made, or threatened to be made, a party to any action, suit or proceeding whether civil, criminal, administrative, investigative or otherwise (including an action, suit or proceeding by or in the right of the Corporation).
- 6.2 Advance for Expenses.** The Corporation will pay for or reimburse the reasonable expenses incurred by a director or officer who is made, or threatened to be made, a party to an action, suit or proceeding in advance of final disposition of such action, suit or proceeding to the fullest extent permitted by law.

ARTICLE 7 Removal of Directors

Any director of the Corporation may be removed at any time, with or without cause, by a vote of the majority of the board of directors then eligible to vote (with such director being deemed ineligible to vote).

ARTICLE 8 Distribution of Assets on Dissolution

Upon dissolution or winding up of the Corporation, after paying or making adequate provision for the payment of all the liabilities of the Corporation, all the remaining assets of the Corporation shall be distributed by the directors of the Corporation for a purpose or purposes similar to those set forth in Section 4.1 of these Amended and Restated Articles of Incorporation, to any other organization that then qualifies for exemption under the provisions of Section 501(c)(3) of the Code. Any such assets not so disposed of shall be disposed of by the court that has general jurisdiction for the county in which the principal office of the Corporation is located, exclusively for a purpose or purposes similar to those set forth in Section 4.1 of these Amended and Restated Articles of Incorporation, or to such organization or organizations, as said court shall determine, that are organized and operated for similar purposes.
