Declines the offer of any food, transportation, lodging or entertainment unless directly related to UWYC business. (5) Refrain from influencing the selection of staff, consultants or vendors who are relatives or personal friends or affiliated with or employed by a person with whom they have a relationship that might give the appearance of partiality. UWYC VOLUNTEERS (1) Should not knowingly take any action or make any statement intended to influence the conduct of UWYC in such a way as to confer any financial benefit on themselves, their immediate family members or any organization in which they or their immediate family members have a significant interest as stakeholders, directors or officers. (2) Should disclose all known conflicts or potential conflicts of interest in any matter to the President, CEO or Board President who will take the matter to the Executive Committee or Board. Board members will make their disclosure to the Board, or to the chair of any committee upon which they serve. They will withdraw from the meeting room during any discussion, review and voting in connection with such matter.
