129 adults (16 and older and not enrolled in public school) received direct instruction to enable them to function on the job, within their families and in society. 32 students completed their high school equivalency diploma. 16 students entered post-secondary education or training. Changes in the data base make it impossible to get accurate numbers on how many students are working, but most of our graduates are in college or they are working, or both.

Explanation of grants: 31 students received scholarships for testing fees for the high school equivalency exam, ranging in amount from \$10 to \$75 per person and totaling \$1,191. Payments were made directly to test vendors and testing centers so the funds could not be use for any other purpose.

English Language/Civics instruction for 6 adults seeking to speak English better and to become participants in the community or to gain citizenship.

Family literacy activities included distributing 575 newbooks to low income children at Head Start. Books were purchased with a contribution from the Bitterroot Valley Kiwanis.
