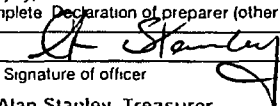

What is the organization's primary exempt purpose?

Mustard Seed Network was founded to facilitate the establishment of new Christian churches- a process commonly referred to as "church planting"- In order to spread the gospel of Jesus Christ throughout the world with a specific focus on the nation of Japan. The Ministry is currently focused on sending missionaries to and establishing churches in the nation of Japan where the number of Christians is less than 1% of the country's entire population. The ministry plans to accomplish this exempt purpose by engaging in the following activities: missionary recruitment, training, and placement, planting churches in Japan, making grants to new and established church plants throughout Japan; raising awareness in U.S. churches and Christians of the spiritual darkness and the need for Christian churches in Japan, and providing administrative support to missionaries and church plants.

Mustard Seed Network is a new entity formed on January 20, 2017. In accordance with its operational plans, significant program service activity is scheduled to begin in July 2017. The program service activity of missionary recruitment, training, and placement for the short period ending June 30, 2017 was limited to communications with prospective missionaries who will become future employees of Mustard Seed Network. This cost Mustard Seed Network \$0 for the short period.

The program service activity of making grants to churches for the short period ending June 30, 2017 was limited to communications and reviews of proposals from churches that are under consideration for possible grants in the future. This cost Mustard Seed Network \$0 for the short period.

The program service activity of raising awareness in U.S. churches and Christians of the spiritual darkness and the need for Christian churches in Japan for the short period ending June 30, 2017 was limited to communications with churches and Christians about possible partnerships in the future.
