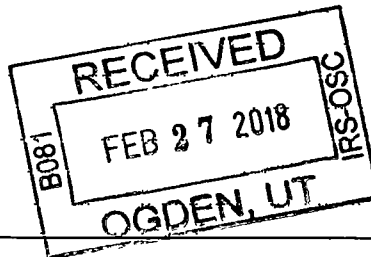

STATEMENT 1

NORTH DAKOTA LIVESTOCK ALLIANCE WAS FORMED BY A VOLUNTEER BOARD IN APRIL 2017 AND RECEIVED ITS CERTIFICATE OF INCORPORATION IN MAY 2017. THE BYLAWS SET THE FISCAL YEAR-END AS JUNE 30. AN EXECUTIVE DIRECTOR WAS HIRED IN SEPTEMBER 2017, AND THE ACCOUNTING SYSTEM WAS SET UP IN NOVEMBER 2017. WITH THE FOCUS ON GETTING THIS NEW ORGANIZATION UP AND RUNNING DURING THE LAST QUARTER OF 2017, THE ORGANIZATION OVERLOOKED THE FILING REQUIREMENT TO REQUEST AN EXTENSION OF TIME TO FILE ITS FIRST FORM 990-EZ WHICH WAS DUE ON 11/15/17. TO PREVENT LATE TAX FILINGS IN THE FUTURE, THE DUE DATES HAVE BEEN FLAGGED AND SCHEDULED, AND A TAX ACCOUNTANT HAS BEEN CONTRACTED.
