The CFO received reportable compensation from CCCS of \$142,945 (per 2016 W-2) and non-taxable benefits in 2016 of \$28,484. The President received reportable compensation from CCCS of \$200,559 (per 2016 W-2) and non-taxable benefits in 2015 of \$30,843. Prairie Rose does not reimburse CCCS for this compensation as services provided directly by the CFO and President to Cathedral Plaza are insignificant.
