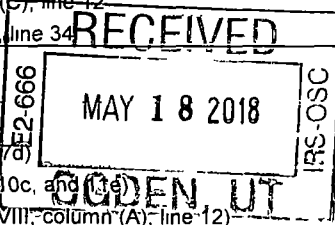

The first sentence of Article I of the Amended and Restated Articles of Incorporation of BASIS Schools, Inc. is amended to read in its entirety as follows:
