Advocacy - 24 hour daily crisis intervention, information, and referral line, providing support and guidance to victims. Advocates meet in-person with victims, at hospital and police stations. Calls are often received from nurses tending to rape victims.

4b (Code:) (Expenses \$ 234,362 including grants of \$) (Revenue \$)

Therapy - One on one individual therapy to the primary victims of rape, sexual assault and abuse, and also secondary victims. Clients may be referred by other service providers. Service is provided to males and females ages 13 and above. Spanish speaking therapists are available for clients most comfortable speaking Spanish.

4c (Code:) (Expenses \$ 21,511 including grants of \$) (Revenue \$)

Prevention - This program is presented to school age children, community groups, and business professionals. Each presentation is tailored to fit the specific audience, in terms of language and level of sophistication. Presentations are designed to dispel the myths about sexual assault, to impart accurate knowledge, to empower individuals and to provide skills to aid in prevention.
