LOCAL CAPACITY BUILDING IAF NW continued its core work of building the capacity of local leaders and organizers to improve the welfare of their local communities. We engaged 150 experienced leaders in 6 IAF Six-Day Leadership Institutes that provided comprehensive training in community organizing principles and built in-depth relationships across diverse constituencies. Those trainings were held in Seattle, Calgary, Brisbane, Auckland, Wellington and Sydney. We organized 3 multi-day seminars/training sessions for the professional organizers, and provided weekly phone consultation and on-site mentoring support to organizers and key leaders from the 11 affiliated organizations. We also supported those 11 organizations in successful campaigns related to expanding affordable housing, creating quality living wage jobs, reducing social isolation and increasing funding for programs that support at-risk children, among others.

REGIONAL STRATEGIC INITIATIVES IAF NW continued to expand its efforts addressing health equity across the region. The organization now provides ongoing training and support for 2 family medicine residency programs— at Swedish Cherry Hill in Seattle and at Oregon Health Sciences University in Portland. This year, the programs made significant contributions to addressing social determinants related to affordable housing (Portland) and physical education for at-risk students (Seattle). The residency programs also served as the catalyst for new organizing initiatives in low income community clinics. Patient organizing efforts were launched in 3 clinics during the year with very promising responses.

The interested person shall not participate in the vote, be counted in ascertaining quorum or participate in any future IAF NW decisions pertaining to the matter.
