Maintained emergency vehicles and provided building maintenance and utilities for the firehall. Purchased ambulance supplies, paid for EMS training, purchased protective gear for firefighters and paid for Workman's Comp. Insurance. Grant of \$1,200 was for fuel to help heat the community center.

 Ambulance service--provided emergency medical care (ALS/BLS) and transport for local community as well as portions of the Parks Highway and the Denali Highway. Provided EMT training and community CPR and first aid training.

 Community of Cantwell, Inc. -- Grant funds received from the Denali Borough for administration were distributed to the fire department and ambulance service via the fire department and ambulance checking accounts. (These grant funds are reimbursed funds--CCI does not receive payment until the funds are spent -- the fire service and ambulance service write checks for the expenses of their service and CCI is reimbursed by the grant funds.)
