From the beginning, community leaders were actively engaged in the planning process and helped define the content, scope, and sequence of the study. Active engagement of community members throughout the planning process is regarded as an important step in completing a valid needs assessment. Instrument Development The adult survey instrument was designed and pilot tested for this study. As a first step in the design process, health education researchers from the University of Toledo and staff members from the Hospital Council of NW Ohio met to discuss potential sources of valid and reliable survey items that would be appropriate for assessing the health status and health needs of adults. The investigators decided to derive the majority of the adult survey items from the BRFSS. This decision was based on being able to compare local data with state and national data. Since U.S. Census Bureau age categories do not correspond exactly to this age parameter, the investigators calculated the population of those 18 years and over living in Umatilla County. There were 55,689 persons ages 18 and over living in Umatilla County. The investigators conducted a power analysis to determine what sample size was needed to ensure a 95% confidence level with a corresponding confidence interval of 5% (i.e., we can be 95% sure that the "true" population responses are within a 5% margin of error of the survey findings). A sample size of at least 381 was needed to ensure this level of confidence. The random sample of mailing addresses of adults from Umatilla County was obtained from American Clearinghouse in Louisville, KY. Procedure Adult Survey Prior to mailing the survey to adults, an advance letter was mailed to 800 adults in Umatilla County. The letter introduced the county health assessment project and informed the readers that they may be randomly selected to receive the survey. The letter also explained that the respondents' confidentiality would be protected and encouraged the readers to complete and return the survey promptly if they were selected. Two weeks following the advance letter, a three-wave mailing procedure was implemented to maximize the survey return rate. The initial mailing included a personalized hand signed cover letter (on Umatilla County Community Health Partnership stationery) describing the purpose of the study, a questionnaire printed on colored paper, a self-addressed stamped return envelope, and a \$2 incentive. The response rate for the Umatilla County adult mailing was 45% (n=342 CI= 5.28%). SAH provides the salary and for a full-time nurse practitioner who provides support for t he high school and middle school clinic. The hospital also supports the clinic's advisory committee with membership representation and space for their meetings to take place. The s ervices provided are what would be found in a local pediatrician's office or family practi ce office. Services include the diagnosis and treatment (including prescriptions) for acut e and chronic illnesses. It also provides the treatment of injuries, immunizations, sport physicals and well-child checks. In essence, SBHCs bring the medical clinic into the schoo l so school staff can refer students immediately for the care they need regardless of their r ability to pay. Plus, they miss less class time! Ninety-nine percent of the students are able to be seen and treated without being referred to their Primary Care Physician. The l ack of availability of the nurse practitioner would hinder the ability to address health c concerns early, before they become critical or chronic leading to poor school attendance. A thletic Trainer SAH supports the athletic programs of both Blue Mountain Community College and Pendleton High School by providing an athletic trainer for their athletes. This servi ce supports the promotion of healthier life styles, quicker access to health care and the prevention of server injuries. Without SAH support for this service these institutions wou ld either have to limit their athletic programs they offer or jeopardize the health of the athletes. Breast Cancer Fund/Cancer Renewal Project These programs help address an import ant unmet need of those who battle with breast cancer. The Breast Cancer Fund helps suppor t women who are being treated for breast cancer. Its main purpose is to provide immediate emergency relief money to breast cancer patients with emergent and/or special needs, such as mastectomy products and transportation assistance. The Cancer Renewal Project helps sup port survivors of cancer by offering them services that help in their recovery. These serv ices include yoga, exercise classes and messages. SAH helps these programs by supporting t he fundraising event "Tough Enough to Wear Pink," with both volunteer support and cash don ations. One hundred forty-three women with breast cancer have benefited from these in this last year. Health Professions Education Health Care Professionals Training This past year we assisted in the training and education of future health care professionals. We do this to help address the need for better healthcare access in rural communities. We subsidized the salary of a nurse educator for the Blue Mountain Community College Nursing Program as well as providing a clinical site and supervision for its nursing students. In addition, we provided a clinical site and supervision for students of a number of other health profe ssions education programs. Diagnostic Imaging, Pharmacy and Physical Therapy. This ensures the availability of health care professionals our rural community. Cancer Conference St. Anthony Hospital sponsors this monthly conference. It is an essential forum to provide mul tidisciplinary consultative services for patients, as well as to offer education to physic ians and allied health professionals. This is the only forum of this kind in the area. Uma tilla County Community Health Partnership St. Anthony Hospital is an active member of this county wide coalition. The purpose of the coalition is as follows: (1) Complete a Compre hensive County-Wide Community Health Assessment and Report, (2) Collaboratively work with t he Partners to develop a 3-Year strategic plan based on the assessment. (3) Participate in the Healthy Communities Partnership in a coordinated effort to address community health n eeds. Pendleton Progress Board Pendleton, like many communities, has been hit hard during t his economic downturn. Hundreds of individuals have lost their jobs and with it their abil ity to pay for basic needs such as healthcare. This is reflected both in the results of th e community needs assessment and in the continued demands on the hospital's charity care. For this reason, St. Anthony Hospital has several members of the Hospital Leadership parti cipating on the Pendleton Progress Board. The Progress Board works on an advisory capacity to the City Mayor. They are committed to making the community an enjoyable and rewarding place to live and work. This includes retention and recruitment of business employers and addressing the community's housing shortage. In addition, it provides services through our federally qualified Rural Health clinic, called the Urgent Care Center and Home Health & Hospice. In 1997, St Anthony joined Catholic Health Initiatives as a market-based organization. This was a blending of the health care ministries of multiple congregations of women religious. While each congregation had carried out the health care ministry of Jesus for many decades, they did so in different locations and in accordance with different traditions. Still, they shared a commitment to building healthy communities in which everyone, especially the poor and vulnerable, would have access to services needed for healthy minds, bodies and spirits. For this reason, it is also committed to serve all persons in the community on a non-discriminatory basis. It operates a 24-hour emergency room 365 days per year that is open to all persons regardless of ability to pay. Community service has always been at the core of St Anthony Hospital's activities. Each year, services and programs are expanded to promote a healthy community. The programs and services described throughout this report not only serve the community, but also reduce the burdens on the government. This commitment is so essential to SAH that it anchors the organization's mission and vision statements which it shares with CHI. To nurture the healing ministry of the Church by bringing it new life, energy, and viability in the 21st century. Fidelity to the Gospel urges us to emphasize human dignity and social justice as we continue to move toward the creation of healthier communities for persons of all ages. St Anthony Hospital and its clinics deliver healthcare primarily to residents in the east end of Umatilla County. This includes the Pendleton community (16,612) and the surrounding area (4448). This includes the communities of Athena, Adams, Helix, Mission, Meacham, Ukiah and Pilot Rock. This is a combined population of this primary service area is 21,060. Our primary service area is determined both by proximity of the residents serviced and the fact the majority of these residents come to St Anthony Hospital for their health care needs. The majority of the population are Caucasian (79%), with the remaining population made mostly of Native American (3%), Hispanic (23%) (Source: Census, 2016). Our secondary service area includes the rest of Umatilla County with a population of 76,531 and the surrounding Oregon counties of Union, Morrow and Grant with a population of 44,165 residents. However, it the residences of Umatilla County that make up the vast majority of those are served by St Anthony Hospital. Good Shepherd Health Systems in Hermiston is the primary health care provider for the west end of Umatilla County. Providence-St Mary Medical Center and Walla Walla General Hospital, both are the primary health care providers for the Walla Walla Valley, which straddles the Washington-Oregon state boarder. The Milton-Freewater area is also located in this valley on the north end of the Umatilla County. Umatilla County, Oregon is home to 76,531 residents, of which, (72%) of residents were adults over the age of 19, 15% were youth ages 12-18 years, and 15% were adolescents under the age of 11. The median household income in Umatilla County (Source: Census 2016-2017) is \$46,980.

CAHs are rural community hospitals that are certified to receive cost-based reimbursement from Medicare. The reimbursement that CAHs receive is intended to improve their financial performance and thereby reduce hospital closures. CAHs are certified under a different set of Medicare Conditions of Participation (CoP). Shortfalls are created when a facility receives payments that are less than the costs of caring for program beneficiaries. Because shortfalls are based on costs, not charges, St Anthony Hospital, due to their designation as a CAH, received cost-based reimbursement for Medicare purposes. St Anthony Hospital will not experience Medicare related shortfalls. Although not presented on the Medicare cost report, in order to facilitate a more accurate understanding of the "true" cost of services (for "shortfall" purposes) the CHI Workbook allows a health care facility not to offset costs that Medicare considers to be non-allowable, but for which the facility can legitimately argue are related to the care of the facility's patients. In addition, although not reportable on the Medicare cost report, the CHI workbook includes the cost of services that are paid via a set fee-schedule rather than being reimbursed based on costs (e.g. outpatient clinical laboratory). Finally, the CHI Workbook allows a facility to include other health care services performed by a separate facility (such as a physician practice) that are maintained on separate books and records (as opposed to the main facility's books and records which has its costs of service included within a cost report). True costs of Medicare computed using this methodology: Total Medicare Revenue \$18,973,539 Total Medicare costs \$19,254,804 Surplus or Shortfall \$(281,265). St Anthony Hospital believes that excluding Medicare losses from community benefit makes the overall community benefit report more credible for these reasons. Unlike subsidized areas such as burn units or behavioral-health services, Medicare is not a differentiating feature of tax-exempt health care organizations. In fact, for-profit hospitals focus on attracting patients with Medicare coverage, especially in the case of well-paid services that include cardiac and orthopedics. Significant effort and resources are devoted to ensuring that hospitals are reimbursed appropriately by the Medicare program. The Medicare Payment Advisory Commission (MedPAC), an independent Congressional agency, carefully studies Medicare payment and the access to care that Medicare beneficiaries receive. The commission recommends payment adjustments to Congress accordingly. Though Medicare losses are not included by Catholic hospitals as community benefit, the Catholic Health Association guidelines allow hospitals to count as community benefit some programs that specifically serve the Medicare population. For instance, if hospitals operate programs for patients with Medicare benefits that respond to identified community needs, generate losses for the hospital, and meet other criteria, these programs can be included in the CHA framework in Category C as "subsidized health services." Medicare losses are different from Medicaid losses, which are counted in the CHA community benefit framework, because Medicaid reimbursements generally do not receive the level of attention paid to Medicare reimbursement. Medicaid payment is largely driven by what states can afford to pay, and is typically substantially less than what Medicare pays.

Some Medicaid plans offer coverage for a limited or restricted list of services. If a patient is eligible for Medicaid, any charges for days or services not covered by the patient's coverage may be written off to charity without a completed application. This does not include any Share of Cost (SOC) or other patient cost-sharing amounts such as deductibles or copayments, as such costs are determined by the state to be an amount that the patient must pay before the patient is eligible for Medicaid. Health and Human Services (HSS) uses the term "Spend Down" instead of Share of Cost. All collection activities conducted by the Facility, a Designated Supplier, or its third-party collection agents will be in conformance with all federal and state laws governing debt collection practices. All third-party agreements governing collection and recovery activities must include a provision requiring compliance with the hospital facilities' financial assistance and billing and collections policy and indemnification for failures as a result of its noncompliance. This includes, but is not limited to, agreements between third parties who subsequently sell or refer debt of the Hospital Facility.
