Nature of Operations and Program Service Accomplishments:

New Hope Christian College (the College) is a private four year and graduate Christian College located in Eugene, Oregon. The College offers degrees in four areas of emphasis: theology, ministry leadership, creative arts and general education. The College also provides room and board facilities for students.

Significant Accomplishments:

Students in our business capstone class were challenged to make a difference in the world, and they delivered. The twelve students worked with Hope International Ministries to drill a well in South India. Villagers have had to walk 3 miles in 100 plus degree heat to find clean water. Many perish due to dysentery and other water-borne diseases.

The class developed a marketing and business plan, set up a social media campaign, established a "Go Fund Me" account, and sent out letters to family members, churches, and local businesses. They raised more than \$500 and then received word in early May that the well was successful. The class turned over their business plan and "Go Fund Me" account to Hope International so this project will continue long after the students graduate.

New Hope Christian College announced on March 8th the appointment of alumnus Wayne Cordeiro as its next president. Dr. Cordeiro will begin his duties on July 1, 2017, shortly after receiving his Doctor of Ministry degree from Capital Seminary. Wayne Cordeiro was the pastor of New Hope Oahu, which grew to 11,500 in attendance. He planted over 150 churches around the Pacific Rim. He is the author of 12 books, designed the Life Journal, and is the general editor of the newly released Life Connect Study Bible.

Aaron Friesen was the featured speaker at the May 3rd commencement. Dr. Friesen is a 2002 graduate of New Hope Christian College. He is currently serving as College and Community Life Pastor at Eugene Faith Center. Among other duties, he pastors Onyx House, a 60 person Christian residential co-op on the University of Oregon campus.

44 Undergraduate students received their degrees in May. This includes the first four to graduate from our Associate of Sciences Program, which is totally online. On the day of graduation, 25 of those students already had jobs in their fields or were accepted for advanced studies.

These graduates are already exercising leadership and making a difference.
