The Foundation manages lifetime contributions and estate gifts with the goal of preserving, protecting, and growing the donors' gift by making it part of a permanent Endowment. The Endowment Fund is managed by professional investment advisors and investment performance is monitored by the foundation's Board of Directors. The Foundation makes an annual grant to the School to assist with need-based scholarship support, curriculum enrichment, and the professional development of faculty.
