Children’s Council supports families by administering child care subsidies on behalf of the state and city in San Francisco. Children’s Council documents family eligibility and pays care providers based on timesheets submitted documenting hours of care. This year, we provided child care support for over 3,300 families and almost 5,000 children. Additionally, Children’s Council manages the centralized eligibility database of families waiting for subsidies, matching children with subsidies as vouchers and subsidized slots become available, and facilitating placements. Through this service, approx 1,000 children accessed subsidized child care and early education in fiscal year 16/17.

Form 990, Part III, Line 4b:

Fiscal Intermediary -In the fiscal year 16/17, Children's Council was the fiscal intermediary for the Preschool for All program. Additionally, we are the fiscal intermediaries for two non-profits including the Child Care Planning Advisory Council (CPAC) and the Family Child Care Association of SF (FCCASF).

Provider Services - Children's Council offers a variety of training, coaching, and consultation for child care providers. In fiscal year 16/17, 245 Family Child Care Centers (FCC's) received individualized coaching and training through our Family Child Care Quality Network. Our Health and Nutrition Department supported 250 FCC's in San Francisco and San Mateo counties through the USDA Child Care Food Program, providing financial reimbursement for serving more than 1,000,000 healthy meals and snacks to the 2,585 children in their care. 87 child care centers, including 49 FCC's, improved the nutrition and physical activity practices in their child care environments by participating in the "Healthy Apple" program, which included a self-assessment, information, training, and additional resources. Children's Council conducted 60 workshops and other educational opportunities in English, Cantonese, and Spanish, for 1,843 participants.
