FORM 990, PART IX - STATEMENT OF FUNCTIONAL EXPENSES	The Statement of Functional Expenses for fiscal year 2016-2017 shows that Program expenses constitutes 72% of total expenses, General & Administrative constitutes 8%, and Fundraising expense makes up the remaining 20%. Fundraising expenses have temporarily increased due to the Cope Family Center's conscious effort to build the infrastructure necessary to support the ongoing expansion of our direct service programs. This continued investment allows Cope to increase and maintain the scale and model fidelity of our programs to serve approximately 31% of the at-risk population in Napa County, a 21% increase over our pre-expansion reach. In subsequent fiscal years, Cope Family Center is positioned to once again expand programming depth and scale. This will bring our non-program expenditures down to our pre-expansion levels of 8% for General & Administrative and 15% for Fundraising.

The current presentation of Cope's Financial Statements includes financial information presented in terms of unrestricted and temporarily funds, and permanently restricted assets. Unrestricted funds are funds that are considered available and accessible to Cope during the stated fiscal year to cover operations. Temporarily restricted funds are funds that are received with a donor-imposed restriction that will be satisfied in the future (generally within one year). The donor's restriction may be for a particular purpose or program or for use in a specified time period. Permanently restricted assets are any assets that are given to a not-for-profit by an outside individual or agency with restrictions on their use or purpose. It is Cope's practice to use the information provided by the presentation of unrestricted funds for the purpose of determining the financial position and informing how Cope uses these funds to fulfill Cope's mission. The exclusion of revenues released from restriction understates our unrestricted financial position by \$335,000. Inclusion of this released revenue shows Cope with a net gain on unrestricted funds of \$120,818 for the current fiscal year. This presentation is consistent with the presentation in prior years.
