Wu Yee's Child Development Department Wu Yee delivers comprehensive services to low- income families and their children, including Early Head Start, Head Start, and California Department of Education programs These services include health and nutrition, family support, mental health, education and support for children with special needs We offer full-day and year-round high-quality subsidized child care services to children age 0-5 through our child development centers, and family child care homes in partnership with our Provider Services Department We also serve pregnant women and children age 0-3 through our Home Based program We served 456 children in thirteen child development centers throughout the city of San Francisco, 32 children through the Family Child Care program, and 110 pregnant women/children through the Home Based program

Form 990, Part III, Line 4b:

Family Services Department The Resource and Referral (R&R) program is one of San Francisco's two citywide child care resource and referral (R&R) programs that mainly funded by the California Department of Education. Our R&R program staff partner with families of all income levels who live in San Francisco to locate child care providers that best meet their needs and provide child care resources to families. A majority of clients are low-income, monolingual Chinese speaking immigrants who are seeking for not only child care but also financial assistance for child care. Our R&R program staff educate families on the child care system, assists families in applying for financial assistance programs, and educates parents on child development and parental rights. We also work closely with child care providers by maintaining a referral database and provide technical assistance and resources to providers. Resource and Referral Program serves approximately 800 families each year. The Joy Lok Family Resources Center (FRC) is a community hub, linking information and resources to families with various needs and offering many programs that target expecting parents, families with young children and parents/caregivers. Our program provides year-round child development and parent education classes, interactive parent-child playgroups for parents and caregivers with children birth through five years of age, a variety of support groups, informational workshops, linkages to community resources and family events to reduce isolation, increase opportunities for parent-child bonding and promote positive parenting in the Chinese community. We help families access multiple resources under one roof including assisting families to assess public benefits such as CalFresh and Medi-Cal and applying for low-income housing opportunities. Joy Lok Center Program serves approximately 300 families each year.

Provider Services Department The Child Care Subsidy Program is a city-funded child care program that provides subsidized child care for eligible families to cover all or a portion of their child care costs We provide case management and child care referrals services to families who are eligible for the program, as well as child care payments to child care providers This is an essential program allowing parents to work or to attend vocational trainings while their children are enrolled in a high quality child care program We served 630 children and 558 families through this city-funded program The Early Head Start Family Child Care Network (EHS-FCC) is mainly funded by the Office of Head Start, California Department of Education and the Office of Early Care and Education We provide children and families with access to quality early learning experiences in a family child care home setting We partnered with family child care providers to provide full-day, full-year child care services to a total of 32 children ages 0-3, allowing their parents to go to school or work Our comprehensive services to children and families include health and nutrition, family support, mental health, education and support for children with special needs The Child Care Provider Training program is mainly funded by the Office of Economic and Workforce Development (OEWD) and California Department of Education This program offers professional and business development support to family child care providers in San Francisco The program provides training, technical assistance, 1:1 coaching, consultation and financial support to child care providers from start-up to program expansion and ongoing quality improvement Program participants are primarily monolingual Cantonese and Mandarin speaking individuals They are applying for initial licensure to operate a family child care business, or individuals who are currently operating a licensed facility and need help with retaining or expanding their businesses and ongoing professional development The Child Care Food Program is one of the sponsors for the Child and Adult Care Food Program (CACFP) in San Francisco CACFP is established by the U S Department of Agriculture and administered by the California Department of Education (CDE) As a sponsor, the program provides food reimbursements monthly to help family child care providers serve nutritious meals and snacks to children Providers also receive training and technical assistance on menu planning, food safety, nutrition and licensing regulations in addition to quarterly monitoring visits from the program Counselor The program serves a total of 120 family child care providers on a monthly average, and about 1800 children in a year The Family Child Care Network (FCCQN) is funded by the San Francisco Office of Early Care and Education (OECE) and First 5 San Francisco The program offers support to family child care providers in order to improve the quality of early care for low-income children in San Francisco Our FCCQN Consultants provide on-site coaching, mentoring, connections to family support services, networking opportunities with events for FCCQN members, scholarships and material resources tailored to the individual provider needs Participating family child care programs are eligible to provide child care services to families receiving City of San Francisco funded subsidies The program serves a total of 105 family child care providers and each provider has their own program consultant to support their work
