COUNSELING & ADVOCACY Safe Nest is dedicated to ending abusive patterns within relationships and stopping the cycle of domestic violence within families. Licensed marriage and family therapists and licensed clinical social workers provide individual and group counseling specifically addressing domestic violence issues. Counseling is provided free of charge for the victims of abuse and for the children who have witnessed or suffered the effects of violence in the home. Safe Nest's state-certified batterer's intervention program, for the abusive partner, is designed to build and promote change, educate and teach non-violent strategies for life. Both voluntary and court-ordered clients are accepted. Perpetrators of abuse pay for Batter's treatment sessions on a sliding-fee scale based on income. Counseling is also available for those experiencing violence in dating relationships. Adolescent programs include a batterers group, designed for teens, which addresses abusive behaviors and teen dating violence. Safe Nest also provides advocacy to help victims navigate the legal system and gain access to community resources. Advocates work with law enforcement, social service agencies and the court systems to increase sensitivity to victim issues. Advocates partner with the courts and law enforcement agencies in Southern Nevada to provide immediate crisis response to victims. Counselors are available at the police departments in Boulder City and Mesquite to provide resources for victims in these communities. Located inside the Family Court, Safe Nest advocates assist victims with the application process to obtain a TPO (Temporary Protective Order) or extended order. There is no fee to apply for a protection order.
