During FY 2016-2017, El Pjaro CDC provided bilingual (English and Spanish) consulting, trainings and business incubation opportunities to underserved entrepreneurs, farmers and micro-businesses throughout Santa Cruz, Monterey and San Benito Counties. Three hundred and seventy-seven individuals received direct services and/or trainings. Clients were assisted with costing, new business planning, marketing, loan packaging and other business related topics. A variety of specialized trainings were provided trainings for family child care providers, food business entrepreneurs, start-ups, farmers and CalWORKs participants. El Pjaro CDC continued to support Plaza Vigil Incubator tenants by providing them with over 734 hours of training, individual business coaching and leadership skills development. During the fiscal year 2016-2017, El Pjaro CDC assisted 32 Small Business owners in preparing loan packages or to access other types of financials resources to start or expand their businesses. Alternative sources included family investment, owner investment, and community lenders. Of the clients assisted 13 have received a total of \$2,874,000.00 capital investments from banks and other lenders. Several client loans are still in progress at the close of the fiscal year. El Pajaro CDCs newest program, The Commercial Kitchen Incubator (CKI) has been in serving Tri-County entrepreneurs for over 4 years and currently 33 small food businesses operate the facility. Six new clients are in the licensing process and four a using the kitchen on a seasonal basis. Since the opening of the Kitchen in 2013, a total of 53 businesses have been incubated from those, 10 graduated to other facilities and 4 closed. El Pajaro CDC is proud of creating this community asset and loves to share the facility with the community by hosting events. Hosting events like the first Event Watsonville, to the City of Watsonville Factory Sale events have drawn more 650 visitors to the facility. Clients face several stumbling blocks in the process not the least of which is financing for their business venture. For many this is their first venture into marketing and sales. We encourage our producers to market themselves by participating in community events and the staff works hard to facilitate these opportunities. In the past year clients have been featured at community events throughout the Tri-County area including the The Corralitos Farm Tour, Pop-Up and Food Lounge in Santa Cruz, among others. Acquiring county and state licensing has proven a challenge for others. Through the experiences of our clients, we are learning and becoming more adept at streamlining the processes for future clients. During the fiscal year ending June 2016, El Pajaro CDC was awarded a \$799K grant from The Department of Children and Families, Office of Community Services Community Economic Development Programs (CED). These funds are being used to support and expand the Kitchen Incubator Program including the construction of small batch co-packing line. This co-packing service will serve as a second layer of incubation by allowing specialty food entrepreneurs and farmers in developing and producing value added products in larger quantities at a larger scale in a more cost-efficient manner. An important goal for this expansion is to create 40 full time jobs at the end of the grant period. At least 75% of these positions should benefit low-income individuals. During year 2016- 2017, El Pajaro CDC worked with a group of professionals to develop the final plans for this facility. Those are currently under review at the City of Watsonville. We are hoping to start tenant improvement in the early fall 2018. The Kitchen incubator also started an access to market strategy that helps entrepreneurs to new markets by allowing them to sell their products at El Pajaro CDC Farmers market booth in 3 different farmers markets in the region. We expect to increase this opportunities by adding other sites and also by opening a new retail store that will offer all the products that are being produced at our Kitchen Incubator.
