IN OUR LARGE CASE MANAGEMENT PROGRAMS, COORDINATED PSYCHIATRIC CARE AND THERAPY SERVICES ARE PROVIDED TO INDIVIDUALS WITH PSYCHIATRIC DISABILITIES, SOME OF WHOM ARE EXPERIENCING HOMELESSNESS. THESE PROGRAMS ALSO OFFER TRANSPORTATION TO MEDICAL AND PSYCHIATRIC APPOINTMENTS AS WELL AS CO-OCCURRING SUBSTANCE USE DISORDER SERVICES. CLIENTS OF THE SACRAMENTO COUNTY MENTAL HEALTH SYSTEM OFTEN FIND THEMSELVES IN CRISIS AND WE PROVIDE A NON-MEDICAL ALTERNATIVE TO EMERGENCY ROOM TREATMENT. TLCS MENTAL HEALTH CRISIS RESPITE CENTER HAS PROVIDED SERVICES SINCE 2013/14. IN THIS FISCAL YEAR NEARLY 3,000 (DUPLICATED) INDIVIDUALS CAME TO THE CRC IN NEED OF RESPITE. STAFF PROVIDE A NON-MEDICAL ALTERNATIVE TO INDIVIDUALS EXPERIENCING A MENTAL HEALTH CRISIS. GUESTS CAN STAY UP TO 23 HOURS AND THE RESPITE CENTER STAFF ARE AVAILABLE 24/7.
