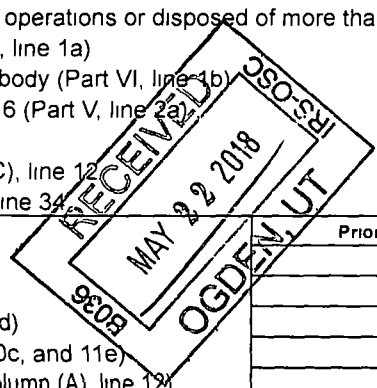

An 18 bed facility is available for women and their children who have left abusive situations. In-house legal advocacy is available and is certified by the Bureau of Immigration Appeals
