Boys Republic provides both residential and non-residential youth services to disadvantaged, at-risk young people from throughout California. It operates six facilities, all in Southern California: a 200-acre residential campus, school, and farm in Chino Hills; two residential group homes for boys in Los Angeles and Pomona; a Girls Republic group home in Monrovia; and two non-residential day treatment centers and schools in the cities of Monrovia and El Monte. Total capacity for all facilities is 208, which includes 168 residential beds and 40 day treatment positions. Boys Republic provides a diverse program of educational, psychological, vocational, and family reunification services.
