Taught by industry experts, participants receive vital training and insight on various topics including distribution, writing, fair use and foundation support. IDA produced 22 Doc U events master classes and seminars with Sheila Nevins, Robby Kenner, Sonya Childress, James LeBrecht and others. Advocacy: IDA works on a range of advocacy issues, including issuing public calls in support of filmmakers whose free speech rights are being curtailed. IDA also participated in Amicus briefs on a range of issues in partnership with the Reporters Committee for Freedom of the Press, and provided comments to the Library of Congress on copyright issues.
