Personal gain may result not only in cases where a Board member or employee has a significant ownership in an organization with which PPPSW does business, but also when a Board member or employee receives any special consideration as a result of any transaction or business dealings involving PPPSW. Board members and employees must avoid any conflict of interest with respect to their fiduciary responsibilities to PPPSW. 1. No Board member or employee shall use her or his position to further the manufacture, distribution, promotion, or sale of any material, product, or service in which s/he has either a direct or indirect financial interest. 2. No Board member or employee shall knowingly accept any gift or gratuity worth more than \$50 from any PPPSW vendor or supplier of goods and services, and in no event will a cash gift or gratuity of any amount be accepted. 3. There shall be no self-dealing or any conduct of private business or personal services between any Board member or employee and PPPSW except as procedurally controlled to assure openness and full prior disclosure, competitive opportunity and equal access to all relevant information.
