Part I, Line 2	Saint Ann's School awards grants to students in the form of scholarships. The scholarship is a reduction of the tuition charge for the academic year. Families applying for financial aid submit an application to the School Scholarship Service (SSS) of the National Association of Independent Schools. The SSS performs an analysis of income, assets, and liabilities in order to arrive at an estimated amount which they consider the family can afford for independent education. These data are sent to Saint Ann's and used by administrators in their decision making. The administration's overall decisions are reviewed by a Board committee to whom the Board has delegated authority to approve financial aid awards. Each year the school accepts several applicants from Prep for Prep, an organization that prepares and supports economically disadvantaged minority students seeking an independent school education. These students are granted substantial need-based financial aid, which reduces the family's contribution often to less than \$2,500 annually. For fiscal year 2017 we budgeted approximately \$6 million for scholarships and other assistance to students. 248 students out of an enrollment of 1,086 (23%) received scholarship aid, allowing the school to fulfill its objective of maintaining a diverse student population.
