1 In the six(6) month time frame of the charity operation, 18 clients/Recipients (3 Adult Men, 12 Adult women, and 3 Children under the age of 18) received long term individual and/or family counseling Most of the clients/recipients had experience past traumatic events needing emotional and spiritual inner healing to restore to a healthier mindful thinking and lifestyle choices.

The outcome of the clients/recipients receiving faith -based counseling promoted healthier coping strategies, restored self image, understanding and applying forgiveness, and positive thinking which lead to healthier choices with boundaries

Program expense - \$4842 40.

2 Low income clients/recipients that needed further individual counseling beyond the closing of the charity were referred to a another faith-based counselor in the community The scholarship funds helped each client/recipient receive a certain number of counseling sessions These funds were given to the Counselors's buisness to fund clients counseling services

The outcome resulted in six (6) clients receiving certain amount of counseling sessions for a reduced cost

Program expense - \$3385 00.

3 The Messenger Center clients/recipients received educational materials to aid in their continued inner healing journey. The outcome is to encourage reading and applying new skills to support clients emotional and spiritual restoration and freedom from past hurts and unhealthy developed habits

Program expense - \$ 1517 00
