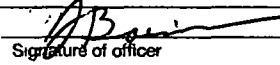

Part III: Statement of Program Service Accomplishments: Primary Exempt Purpose

What is the organization's primary exempt purpose? To empower individuals with the necessary tools to pave a great future by providing alternatives for economic advancement through entrepreneurship, business development, and job training with the intent to create opportunity and financial sustainability while stimulating social change and responsibility through community involvement and service.

1st Accomplishment. Paving Great Futures' "C.H.A.M.P." program

In one short year, starting with Paving Great Futures' signature program, "Culinary, Hospitality, Administration, Management, and Program (CHAMP) provided participants who were high-need at risk individuals who had difficulty becoming employed based on either past record or their lack an employable skills to earn a living wage while learning the essential and professional skills in the culinary industries.

Paving Great Futures has been helping high-need at risk individuals to gain employment, become entrepreneurs, and develop into exemplary leaders who have a positive impact in their underserved community. The CHAMP class' participants were taught the tools of culinary skills, job readiness skills, entrepreneurship, financial literacy, responsible life skills, and on the job training.

In addition, those 21 students who successfully graduated from Paving Great Futures' (PGF) CHAMP classes were provided On- the-job- training(OJT) through its Champion Catering and Flippers Fish & Chicken mobile catering OJT programs. Initially, the OJT trainees trainees received a small stipend and now they are receiving the minimum wage of \$13.00 per hr.

Furthermore, with grants from the San Diego 4th District, SD Mayor, and Chefworks, Paving Great Futures (PGF) was able to purchase equipment and other necessities to launched its mobile catering service, Flippers Fish & Chicken giving its OJT trainees the opportunities to culinary skills in the mobile catering industry. Flippers Fish & Chicken OJT trainees market their skills in Farmer markets, street fairs and other venues.

Finally, Paving Great Futures has received recognition from Chef Works Cares, the charitable initiative from global uniform designer and manufacturer Chef Works, gave its largest grant of \$25,000 to PGF's C.H.A.M.P. It stated that "C.H.A.M.P is poised to become a guiding a guiding force for those who may have otherwise felt without a way to economically advance themselves, C.H.A.M.P. paves the way for unlimited financial stability." 2nd Accomplishment: Leadership and Civic Engagement Development (L.A.C.E.D.)

Besides successfully educating and training high need at risk and unemployed individuals to obtaining gainful employment, Paving Great Futures provided a 10 weeks pilot program, Leadership and Civic Engagement Development (L.A.C.E.D.) to educate and developed leadership and increase civic engagement of the residents in Southeast San Diego. L.A.C.E.D. program was divided into four sections: 1) Community Engagement and Leadership, 2) Political Engagement and Leadership, 3) Criminal Justice System Engagement and Leadership, and 4) Don't just stand there do something. We had an average of 20 participants weekly for a two-hours class session. The classes were taught by the professionals where the shared analysis and outlook on topics through their viewpoint.

PGF's L.A.C.E.D. program produced two significant results that positively impacted Southeast San Diego community. One it increased the community civic engagement and representation in local government advisory board and committees. For example, two PGF's member have been appointed to the Citizen Advisory Board. In addition, two community residents were appointed to the Proposition 47 committee which determined how Prop 47 funding will be allocated for mental health services, substance-use disorder treatment, diversion programs, job skills training, or supplemental housing-related services. Further, one individual was appointed to the San Diego County Gang Commission which focuses on gang intervention and prevention. Finally, one of our youth participant, a 5th grader, was selected to attend the Junior National Leadership Conference for 2017 in Washington, D.C. The fifth grader, a little girl of Southeast San Diego community will have the opportunity to view the nation's capital, experience the power of democracy among the monuments, and collaborate with her peers to discover solutions to some of the issues they face today.

Moreover, our second significant result from the L.A.C.E.D. program brought people together from political, criminal justice, law enforcement and community together to discuss their various points of views on topics that affects Southeast San Diego and San Diego as a whole. In a nutshell, L.A.C.E.D. provided a forum to foster a better understanding between the various stakeholders.

Finally, after the successful 10 weeks L.A.C.E.D. was completed, we conducted a monthly series of L.A.C.E.D topics such as community leadership, political leadership, and criminal justice systems.

3rd Accomplishment: San Diego Youth Hip-Hop Summit 2: I Keep It Global

Paving Great Futures & #JUSTICE4SD33 along with local San Diego hip hop artist will gathered youth between the ages of 12 and 17 in a summit to educate them on the music business, unity, conflict resolution, continuing their education, and responsible life skills. Over seventy youth participated in the event which was held at San Diego State University campus. There will be a panel of well known locally respected artist that will discuss these topics using Hip Hop as the vessel to capture the youth's hearts and minds. After the panel discussions, we held a positive song creating contest. The first place winner won a free production of their song, professional music video production of the song, and on stage performance at upcoming community event.
