A MIXTURE OF 59 ADULTS AND CHILDREN PARTICIPATED IN THE RESPITE PROGRAM. THE HOURS ARE BEFORE AND AFTER PROGRAMMING, WHICH EQUATES TO 7:00 AM TO 9:00 AM AND FROM 3:00 PM TO 6:00 PM.
