Sources of revenue are \$23,000 from the annual campaign and the net proceeds of the Distinguished Speaker Luncheon which totaled \$227,809. The Parents Association had expenses for the following: organizing the parent school coffee, providing the teacher appreciation lunches, purchasing coffee for the school workrooms, teacher Christmas bonuses, salary increases, and printing the school directory. Net income over expenses was granted to the school athletic department to pay for uniforms, equipment and playoff expenses.
