Grantmaker's Description of How Grants are Used	Luria uses a company called FACTS for financial aid determination where parents create an account and submit tax returns & W-2's. In addition they answer a questionnaire about household expenses and FACTS calculates need based on the amount that is available for Luria to distribute that school year. A committee including one professional from the school and 2 other outside independent individuals meet to determine allocations based on the information provided from FACTS. Once the decision is made parents have the ability to appeal which is communicated to the committee through the Head of School.
