During fiscal year 2016-2017, Live It Learn It (i) delivered more than 475 academic sessions for nearly 2,000 students and (ii) trained nearly 25 current and future classroom teachers to conduct Live It Learn It programming on their own. Average student achievement nearly tripled from pre to post assessment, and achievement levels for the top 80% of our students more than quadrupled. Our Ward 7 (East of the River schools) have the highest growth so far
