

The focus of the panel was to explore ideas for gathering information on numbers and trends in the area of immigration consultant fraud. The Commission, along with the Unaccompanied Minor Immigrant UMI Working Group, convened the National Conference on Representation and Advocacy for Unaccompanied Immigrant Children in Houston, Texas on December 13-15, 2017. The conference presented three days of programming specific to the immigration practice of representing unaccompanied children and is the first conference of its kind in 9 years targeted towards the legal service provider community. The Childrens Immigration Law Academy, a project of the Commission, organized a 3-day conference for 70 legal service providers to immigrant children. The conference took place in August 2017, and was held in coordination with the National Institute for Trial Advocacy.</p>

The CBCC team hosted five regional Court Improvement Program grantee meetings throughout the country. These meetings brought together several hundred participants in total, and included state judges, court personnel, and child welfare agency staff from almost all fifty states, Washington DC, Puerto Rico, and the U.S. Virgin Islands. The two-day working meetings focused on initiatives that improve outcomes for children and families in the child welfare system in each state. In collaboration with the Education Law Center and the Juvenile Law Center, the ABA formed the Legal Center for Foster Care and Education to provide national advocacy on policy matters affecting the education of children in foster care. In 2017, the ABA Center developed a state-to-state technical assistance tool that will help states share information about how they implement federal provisions in the Every Student Succeeds Act that support school stability for children and youth in foster care. The project also launched a new website focused on Educational Success for Youth in Juvenile Justice in 2017. The ABA Centers National Alliance for Parent Representation helps parent attorneys provide the highest quality representation so families involved in the child welfare system remain intact. This initiative includes an active listserv of over 1,100 members, a biennial national parent attorney conference, a series of leadership forums and training and technical assistance provided to parents attorneys. This project is currently working in Louisiana, North Carolina, Mississippi, Oregon, South Carolina, Iowa, and California. In partnership with other national organizations, the Center manages the Grandfamilies Project and website, Grandfamilies.org. This project provides legal resources for kin who care for children within and outside the child welfare system, and to professionals who serve kin as attorneys and policy advocates. In 2017, the ABA Center on Children and the Law published a wikiHow of Kinship Foster Care to help create a child welfare system that consistently promotes kinship placement, helps children in foster care maintain connections with their family, and tailors services and supports for kinship foster families. The project also re-launched its www.Grandfamilies.org website in 2017. In 2017, the ABA Center on Children and the Law launched the Family Justice Initiative FJI, a new grant-funded project that unites advocates for children and advocates for parents around a shared goal that every child, and every parent has high quality legal representation when child welfare courts make life-changing decisions about their families. FJI is led by the ABA Center on Children and the Law in partnership with two other organizations and the volunteer support of more than 50 attorneys.</p>
