CURRICULUM AND INSTRUCTION FOR STUDENTS IN GRADES 1 THROUGH 12 ARE BASED ON THE BELIEF THAT STUDENTS WITH LEARNING DISABILITIES LEARN BEST WHEN INSTRUCTION ADDRESSES INDIVIDUAL STRENGTHS AND WEAKNESSES. TO FACILITATE THIS BELIEF, EACH STUDENTS COGNITIVE, ACADEMIC AND SOCIAL STRENGTHS AND WEAKNESSES ARE IDENTIFIED, AND AN INDIVIDUAL EDUCATIONAL PROGRAM IS DESIGNED. STUDENTS ARE GROUPED INTO SMALL CLASSES, METHODS AND MATERIALS ARE GEARED TOWARD INDIVIDUAL NEEDS, AND STUDENTS ARE ACTIVELY ENGAGED IN LEARNING THROUGH MULTI-SENSORY INSTRUCTION. TEACHERS GUIDE STUDENTS LEARNING BY COMBINING PROFESSIONAL EXPERTISE WITH COMPASSION, RECOGNIZING THAT THE FOUNDATION OF LEARNING IS THE HUMAN RELATIONSHIP DEVELOPED BETWEEN

ESTABLISHED IN SEPTEMBER, 2015, THE LEARNING CENTER AT GROVES ACADEMY PROVIDES AN ARRAY OF FEE-BASED SERVICES TO BOTH GROVES STUDENTS AND THE TWIN CITIES COMMUNITY. THESE SERVICES INCLUDE DIAGNOSTIC TESTING, TUTORING, ASSISTIVE TECHNOLOGY ASSESSMENTS AND CONSULTS, SPEECH AND LANGUAGE ASSESSMENTS AND THERAPY, AND CAREER AND POST-SECONDARY COUNSELING. OUR SUMMER PROGRAMS OFFER A VARIETY OF ACADEMIC AND ENRICHMENT PROGRAMS FOR STUDENTS IN GRADES 2 THROUGH 12. THE LEARNING CENTER IS ONE OF THE FEW SITES IN THE TWIN CITIES THAT OFFERS ALL OF THESE SERVICES UNDER ONE ROOF, AND MANY OF THE LEARNING CENTER CLIENTS PARTICIPATE IN MORE THAN ONE SERVICE.
