

Statement of Reasonable Cause for Late Filing

Upon completion of the fiscal year 2015 (8/31/2016) Form 990-EZ, it was our understanding that our activities would be filed under an umbrella PTO organization for the Webster Groves School District. We did not file the 2016 or 2017 returns under this understanding.

It came to our attention that we were not filing under the umbrella organization in 2019. At that time we filed an extension for the 2018 return and started working on the 2016 and 2017 tax returns.
