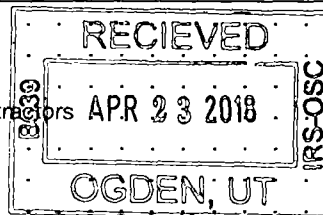

A new national ENDOWMENT FUND WAS CREATED from monies donated by the Cooley ESTATE. The fund establishes a "Faith In Action" grant to support a charitable (501(c)(3)) project in which AN ACTIVE or Alumnae member is involved in a leadership role. The grant is awarded every 2 years at our National meeting. The grant must go to a 501(c)(3) organization in which a Kappa Phi active or recent alumna is involved in a leadership role. The organization must be a non-profit christian-based service organization. A committee is established to review applications. The endowment is \$11,000. One-half all new contributions will be added to the endowment. The other half of new contributions and all income earned may be used to fund the grant.
