The trustee does not have the discretion to vary either the beneficiary or the amounts payable to the beneficiary unless there is a default of failure of the charitable purpose. There is a considerable amount of joint effort and cooperation between the trustee and the representatives of the YMCA in carrying out the charitable purposes of the Trust. This joint effort and cooperation is not only a practical necessity in carrying out the charitable designs of the testators, but is also mandatory under the terms of the Trust's governing instrument.
