The East Cooper Outboard Beneficent Group is our 501(c)(3) Charitable Organization that then donates this money to worthy local 501(c)(3) charities. Some of the charities that receive money are East Cooper Meals on Wheels, My Sister's House, scholarships to needy students, Coastal Conservation Association South Carolina, and many more. The East Cooper Outboard has been raising money thru our Turkey Shoot for over 50 years.

These meeting are critical in making sure our donations are used wisely. The meeting also allows for marine biologists and conservationists the opportunity to meet with over 100 boat owners and fisherman at each meeting.
