THIS ELEVATES THE AVERAGE COST OF EACH WISH TYPE, AS USED TO DETERMINE THE TOTAL LIABILITY. HOWEVER, THE IN-KIND IS OFTEN SOMETHING THAT ENHANCES THE WISH AND MAY VERY WELL BE AN ENHANCEMENT THAT WE WOULDN'T PROVIDE IF WE HAD TO PAY FOR IT, IN OTHER WORDS, THESE IN-KIND ENHANCEMENTS ARE OFTEN BEYOND OUR PROMISE TO GRANT THE WISH. WHILE THE IN-KIND GOODS AND SERVICES MAKE FOR BETTER WISHES, THEY ALSO HAVE AN UNFAVORABLE EFFECT ON OUR LIABILITY FOR PENDING WISHES. AS SOON AS A WISH HAS BEEN DETERMINED FOR A QUALIFIED WISH CHILD AND THE WISH MEETS OUR GUIDELINES, THAT WISH IS ADDED TO OUR PENDING WISH LIABILITY. BY DEFAULT, ALL WISHES ARE ADDED TO THE LIABILITY, ALTHOUGH SOME WILL NOT BE GRANTED FOR MORE THAN A YEAR. THIS CALCULATION OF LIABILITY EFFECTIVELY REDUCES THE CHAPTER'S ASSET TO LIABILITY RATIO (BUT ALSO SHOWS THAT WE HAVE ALREADY BEGUN TO PROVIDE THE BENEFIT OF HOPE AND STRENGTH ASSOCIATED WITH DEFINITION AND PLANNING OF THEIR WISHES). WHILE THE LIABILITY IS A DEMONSTRATION OF THE NEED WITHIN OUR COMMUNITY TO REALIZE THESE WISHES, THE COST IS MUCH LESS AND THE TIMEFRAME LONGER THAN IMPLIED THROUGH THIS REPRESENTATION. OUR NATIONAL CFO IS CURRENTLY EVALUATING THIS CALCULATION AND MAKING A PROPOSAL FOR A DEFINITION THAT MORE CLOSELY EVOKES THE REALITY OF OUR PROMISE TO OUR CHILDREN AND ASSOCIATED LIABILITY.
