The Joint Commissioned Accredited Clinical department provided 5,691 adolescents and adults substance use related counseling, assessment, education, and peer-led treatment sessions. Clinical also provided information and referral services in over 9,698 phone calls in both English and Spanish. Behavioral Health/PTSD counseling services were provided to 144 veterans and their families through the Veteran's programs. In addition, general assistance funds were distributed to 824 veterans and their families. The results of the Veterans program was evaluated independently by UNTHSC. Housing and case management services were provided to 45 formerly homeless clients while networking with other organizations to provide a holistic approach to overcoming obstacles facing homeless clients. The homeless were also served through the Healthy Community Collaborative where 218 homeless persons received a mental health diagnosis and 179 different homeless persons received 450 counseling sessions.
