Friends of the Artesia Public Library contracted artists to add a stained glass door in the Library to herald the entrance to the Special Collections Room and to have a bronze bench created that honors the founding documents of the United States of America. Other projects included providing funding for the Summer Reading Program and purchasing a set of books aimed at youth whose interest is football. This group of volunteers also holds events, such as the Books N Bites, to promote reading; book sales to help books culled by the library find new homes and various events to celebrate reading and learning. In order to promote interest in the Peter Hurd Mural featured in the library, they also sell mugs, postcards, calendars and prints that feature the mural.

My Neighborhood is a group of volunteers that have raised funds to create a Community Garden on an empty lot provided by the City of Artesia in an economically challenged neighborhood. My Neighborhood hopes to provide a sense of community ownership and stewardship while fostering the development of a community identity and spirit. Not only will this beautiful spot provide a common meeting spot to get to know neighbors, and, hopefully lead to crime prevention and community leadership in the residents, it will also provide these families the opportunity to grow fresh, healthy food for their families. This garden will also offer the opportunity for local schools to teach first hand lessons surrounding the agricultural arena, including where food comes from, math, economics, environmental responsibility and stewardship.

Packs of Love provides sacks of easy-to-prepare foods weekly on Friday to school kids whose only meals are those provided at school. The students are recommended to the program by school counselors. Packs of Love also provides food bags and meat vouchers to the families of participants at Thanksgiving and Christmas.

Ride for Bikes provides bicycles at Christmas for all Artesia Kindergarten students. They also provide scholarships to Eddy County high school graduates that have faced and overcome a challenge in their lives. Scholarship recipients are chosen by a committee that reviews the essays submitted by applying seniors. The scholarship is renewable for up to eight semesters, dependent on grades and attendance.

Ride for Bikes holds one fundraiser each year. The Wet N Wild is a 4K walk, run, bike or skate event during which local volunteers employ creative ways to get the participants soaking wet.

SENIOR SALUTE Exp \$22,582 Grants \$0 Revenue \$0

This event is an all-night lock-in that provides great food, decorations and games/activities to help high school seniors celebrate their graduation in a safe, alcohol and drug free environment. Seniors' parents collect donations from local businesses and individuals, which is used to purchase minimal supplies for decorating and activities. The bulk of the donations go to purchasing prizes, which are used as incentive to draw seniors to this event. The prizes are given out at the end of the event (6 a.m.) and anyone leaving Senior Salute forfeits all winnings. Approximately 150 high school students participated in this year's event, and gifts to the high school seniors totaled \$21,000 in cash prizes.

CHANGING LIVES COALITION Exp \$20,000 Grants \$20,000 Revenue \$0

Changing Lives Coalition is the dependent 501(c)(3) that was formed from two funds previously sponsored by Greater Artesia Foundation: 7024U Youth Outreach and Artesia Drug & Crime Coalition. The board of directors of GAF granted this money when the organization made the decision to become an independent organization, on the contingency that the new organization proved viable.

ARTESIA ARTS COUNCIL Exp \$12,000 Grant \$12,000 Revenue \$0

Greater Artesia Foundation granted funds to an Artesia 501(c)(3) organization to renovate an historic office building downtown. Artesia Arts Council provides office space in the front of the building for the local MainStreet organization at no cost, and the back part of the building is now used as an art gallery and event venue.
