Five retreats were provided: a Youth Overnight Retreat, a Youth Day Retreat, a Concord Day Retreat, a Con Brio Overnight Retreat, and a Con Brio Day Retreat.

Rehearsals/Instruction: Rehearsals are the primary focus of the organization, providing music instruction to singers aged four through adult. Rehearsals allow our members to improve and hone their skills to become better musicians and singers, as well as to learn music in preparation for concerts, performances on tour, community outreach concerts, and other musical events in which we participate. Rehearsals teach the singers basic music skills, how to read music, music theory and sight-reading, and help the singers improve vocally as an individual as well as a choir member.
