GRANTS IN ISRAEL. Grants to Israel helped to accomplish the following: Expansion of Haifa school into first grade. Expansion of Tel Aviv-Jaffa school into second grade, and opening of additional preschool classes. Expansion of Shared Communities program to over 2500 Jewish and Arab adults' participation. Doubling of the number of students in Hand in Hand's newest school in Beit Berl. The alumni program for Hand in Hand high school graduates grew both in the number of graduates, and in the number of gatherings the group has had over the last year. There were local meetings and programs in Jerusalem and Galilee, as well as national conferences, and weekend retreats. Continued professional teacher training. Creation of new multicultural curriculum for history and civics classes for junior high and high school.

EDUCATIONAL WORK IN THE US. The Executive Director and representatives from Israel had numerous speaking tours around the US, presenting in synagogues, churches, universities and at large-scale events, helping to educate the public about Jewish-Arab relations in Israel. Approximately 60 presentations were given in the following cities: Portland, Seattle, San Francisco, Los Angeles, Minneapolis, Houston, New York, Baltimore, Boston, Chicago, St. Louis, Miami, Sarasota, Oakland, Denver, Ann Arbor, and Pittsburgh.
