To inspire passion for the circus arts through training, performance, and community outreach. In FY 2017, we provided 6,000 classes to over 25,000 trainees, produced 7 Cabaret shows and 6 Student Showcases.

Training: Circus Center offers classes for every level of ability in flying trapeze, acrobatics, aerial arts, contortion, juggling and many other disciplines. We have training for all ages, from our recreational and pre-professional youth programs serving students as young as 6 years old, to our recreational adult classes and private lessons. This year, we relaunched our Clown Conservatory professional training program under new leadership, with 11 full-time students. Our world-renowned team of instructors and coaches have performed with the Nanjing Acrobatic Troupe, Moscow Circus, Cirque du Soleil, Pickle Family Circus, Circus Bella, Circus Smirkus, Teatro ZinZanni, Ringling Bros. and Barnum & Bailey, and the Big Apple Circus.

Outreach: Circus Center partners with schools and community organizations to offer circus arts activities to under-served young people. This year we launched a weekly adaptive circus program in partnership with a school for children with autism and other cognitive challenges. For those young people who get bit by the circus bug, we offer generous need-based financial assistance and other support for their participation in all of our on-site youth programming. This year, we also started a regular series of community open houses to provide low-barrier introductions to the world of circus. Finally, this year Circus Center's top artists and instructors led panel discussions and interactive activities with over 1,000,000 visitors to

Performance: Circus Center produces a 7-show season of professional performances in our Circus Center Cabaret series. These shows employ dozens of circus, music, and variety artists annually. We also produce 3 professional-quality shows annually, two performed by the trainees in our Clown Conservatory professional training program, and 1 performed by the San Francisco Youth Circus, our pre-professional youth training program. Finally, we offer multiple student showcases, artists-in-residence shows and works-in-progress presentations, and more. Collectively our performances serve thousands of audience members every year, all at accessible ticket prices.
