This memorandum of understanding must be signed and returned to VSF prior to funding the grant. The organizations W9 must also be provided. Organizations that have received grant funding from VSF are required to submit a 250 - 500 word narrative on the uses of the funds including visuals of the work performed, when possible. 25% of the grant award is withheld until the narrative has been submitted. If an applicant does not submit its narrative, it will not receive the final 25% of the grant award and VSF will not consider them eligible for future grant funding.
Additional Information for Schedule I	Grant applications must be initiated by March 31. The VSF Board is presented the applications and then each grant application is assigned to a Board Member who reviews the grant application and preliminarily decides to accept or reject the application. All Board Members participate in the vote to accept or reject all applications. Accepted grants are reviewed in further detail. Grant requests are compared to available funding and the final decisions are made. The motion to fund grants is documented in the minutes of the board meeting. The VSF Board approves grant applications and records a grant payable if and when grants are approved by the Board. If the grantee does not supply VSF with certain documents, VSF will not disburse any grant funds and will write off the grant. Occasionally, the grant write-off occurs in the year following the award and thus the write-off reduces the current year grant expense. During 2017, the grants awarded and noted in Schedule I exceed the amount of grant expense in Part IX Line 1 because \$20,681 of grants awarded from prior years were written off for failure to provide the necessary information for the final payment.
