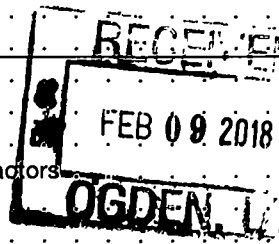

The majority of our spending goes directly to schools in Zimbabwe where we pay for school fees and required expenses for 38 orphans.

During this fiscal year, we paid for 9 children to attend local primary or secondary schools (\$10,022), 13 children to attend boarding

schools (\$44,529), 11 children to attend skills building programs or technical schools (\$31,250) and 3 students to attend

university (\$11,519). In addition, we covered medical expenses and incentives for strong academic performance (\$3,697), and

supported activities run at a drop-in orphan care center (\$5,000).

This year we spent \$288 on office supplies, \$4,018 on bank fees, \$249 on taxes and filing fees, \$397 on travel and meetings, and

\$200 on website maintenance. The total of these expenses is \$5151
