CARE provided funding to 2 new projects at Mayo Clinic of Arizona under the direction of Drs Bryce & Murtaza. The first focuses on optimizing drugs to patient's tumors. Melanoma tumors will be transplanted into humanized mice. Known drugs and immunotherapies will be tested and correlated with DNA sequences controlling known tumor genes. In this mouse host-human tumor system, drug combinations and new biologics can be screened faster, at lower cost than in clinical trials in humans. This is leading to quickly to novel human clinical protocols. The 2nd project focuses on advancing the uses of liquid (blood) biopsies for early detection and diagnosis. Tumor DNA fragments can now be detected in the bloodstream and sequenced. This can facilitate early cancer detection and drug response monitoring.

Form 990, Part III, Line 4b:

CARE continued funding the Early Detection/ Cancer Interception Program at the Virginia G. Piper Cancer Center at HonorHealth under the direction of Drs. Erkut Boraznci, & Daniel Von Hoff, in collaboration with many major cancer centers in the US, UK (Memorial Sloan Kettering, Beth Israel Deaconess, University of Pittsburgh Medical Center, SU2C- Stand Up to Cancer Dream Team leadership. This program is working initially with healthy individuals at high risk for pancreatic cancer by conducting medical history and physical exam, genetic testing & counseling, blood testing and MRIs and other imaging studies. Participants receive comprehensive review of risk factors, multiple ways to reduce their risks and a personalized plan for cancer prevention. The program is working with pancreatic cancer families that has led to detecting other cancers too. Through the new hardware/software system acquired with CARE's funding, vital data is being collected to help identify common patterns, characteristics and trends help to intercept and defeat cancer at much earlier stages than possible before. C-13-Pyruvate spin detection technology is being used to detect very small tumors (resolution is < 1mm in mice)). Clinical trials are underway with new and "old" drugs (e.g. Tassigna-Novartis, 2nd generation Gleevec for chronic myelogenous leukemia, Vitamin D derivatives & Immunotherapeutics). Continued funding Dr. Ronald Korn's efforts in making the Rapid Detection and Assessment of Response (RADAR) program a reality. This technology uses non-invasive, highly specific analytic tools and imaging techniques to monitor a patient's response to chemotherapy or radiation to determine, within a few days, whether a patient's treatment is working. This technology is being used in part to determine sensitivity for detection of cancer, prediction of tumor aggressiveness on mammograms and tumor responses in certain clinical trials. Continued funding has enabled the program to go from the research phase to the trial phase in evaluating patient scans vs. physical properties of tumors.

In the ongoing seminar series "Live Long & Prosper", we focus on the latest trends in cancer research, treatment, prevention and wellness strategies. We host seminars and presentations with researchers, physicians and experts from HonorHealth (formerly Scottsdale Healthcare) and Mayo Clinic to address a wide variety of topics for multiple audiences at the Desert Mountain community.
