IN FY17, CODAC SERVED A TOTAL OF MORE THAN 16,000 INDIVIDUALS AND FAMILIES. CENPATICO INTEGRATED CARE NAMED CODAC AS IS FIRST ADULT CENTER OF EXCELLENCE. CODAC'S MEDICATION ASSISTED TREATMENT PROGRAM WAS ALSO NAMED A CENTER OF EXCELLENCE. CODAC WAS AWARDED THREE SUCCESSFUL VICTIMS OF CRIME ACT (VOCA) GRANTS, RESULTING IN OVER 400,000 IN ADDITIONAL GRANT FUNDS FOR SACASA. CODAC BUILT AND OPENED THE GILA HOUSE, A 10-BED BRIEF INTERVENTION PROGRAM (BIP). THIS IS ONE OF ONLY TWO CENPATICO INTEGRATED CARE (CIC) APPROVED FREE-STANDING BIPS IN PIMA COUNTY. THE HELEN HOUSE BIP ALSO LICENSED. RAISED 40K+ THROUGH DINE OUT FOR SAFETY EVENT TO SUPPORT SURVIVORS OF SEXUAL ASSAULT AT SACASA. CODAC RECEIVED A LETTER OF ACKNOWLEDGEMENT FROM THE US DEPT.
