TRAILS SYSTEM (SSTS) IS COMPRISED OF MORE THAN 4,700 MILES OF
INTERCONNECTED SNOWMOBILE TRAILS THAT EXTEND FROM THE CANADIAN BORDER
IN THE NORTH, TO THE MASSACHUSETTS BORDER IN THE SOUTH, AND FROM THE
NEW HAMPSHIRE BORDER IN THE EAST, TO THE NEW YORK BORDER IN THE WEST.
THROUGH THE STATE OF VERMONT, VAST HAS BEEN AWARDED A COOPERATIVE
AGREEMENT AND PARTNERSHIP WITH THE STATE OF VERMONT FOR THE FUTURE
DEVELOPMENT, MAINTENANCE AND MANAGEMENT OF THE SSTS. TO THIS DATE,
VERMONT IS THE ONLY STATE, OF 27 SNOW-BELT STATES, TO OPERATE ITS SSTP
IN PARTNERSHIP WITH A PRIVATE NOT-FOR-PROFIT CORPORATION. FUNDING FOR
THIS PROGRAM COMES THROUGH THE STATE OF VERMONT, AGENCY OF NATURAL
RESOURCES, DEPARTMENT OF FORESTS, PARKS AND RECREATION, AND IS FROM THE

VERMONT, THROUGH THREE OF VERMONT'S REGIONAL PLANNING COMMISSIONS,
DEVELOPED A REQUEST FOR PROPOSAL FOR THE FUTURE USE OF THE OLD LAMOILLE
VALLEY RAILROAD. VAST WAS ONE OF THREE RESPONDENTS TO THE RFP, AND
ULTIMATELY, THE PROPOSAL FROM VAST, TO CREATE A 93 MILE LONG
FOUR-SEASON RECREATIONAL TRAIL, WAS SELECTED AS THE BEST USE OF THE OLD
RAILROAD. VAST HAD BEEN USING THE OLD RAIL BED AS A PART OF ITS SSTS
FOR NEARLY FIVE YEARS PRIOR TO THE RFP'S ISSUANCE. VAST CREATED A
COMMITTEE CALLED THE LAMOILLE VALLEY RAIL TRAIL COMMITTEE (LVRTC) TO
OVERSEE THE DEVELOPMENT OF THE PROJECT. THE LVRTC IS COMPRISED OF
REPRESENTATIVES FROM BOTH MOTORIZED AND NON-MOTORIZED RECREATIONAL
